    - Strategic Plan
      - Nicole Madden and Erin Taylor provided a brief overview of the strategic planning document. Further discussion at January meeting to include a possible motion.
    - CSAA Mini Grant for Social Media Director
      - Erin Taylor proposed applying for a CSAA mini-grant to fund a paid intern who will help manage the LAC website and other social media platforms. This initiative aims to support the strategies and objectives outlined in the Strategic Plan.
      - Commissioner Boyer moved to support the mini-grant application; Lori Christenson seconded the motion.
